c. Motion Item #3: Approval of Low Bid for Parking Lot Construction: Hallman explained that Accurate Excavators bid was \$55,675 and our Engineer has been talking with the Drain Commissioner. They are taking all the water from the site. This will save us over \$40,000 since haul off will not be anywhere near what we were planning on.

d. Motion Item #4: Farmers Market / Water Tower Park – Land Swap: Jernberg explained that back in 2014 we did a property swap that was filed incorrectly. We would like formal approval to get this property swap filed appropriately and done.

e. Discussion Item #1: Farmers Market / Water Tower Park – North Boundary Line: A small piece of property belongs to The Depot. We have come to an agreement for an easement swap. However, we could make a cash offer instead, if we prefer. Jernberg suggested an offer of \$5,000 for the twenty-foot (1,380 square

feet) strip of property. We have not spoken to The Depot about this yet, wanted to discuss with the Commission first. The easement swap would be the park area for parking spaces on the other side of the caboose

**Unanimous Consent** of the Commission to allow the City Manager to proceed with either the cash offer or the easement swap based on conversation with The Depot.
