 - a. River Country Chamber of Commerce: Pam Schwallier provided an update. They had the 5th annual membership meeting at Legends Ranch. They helped sponsor the Pitch North competition. Pam discussed tourism, updated everyone on the upcoming golf outing and Memorial Day celebration. This year they are having an art competition. The Chamber is having a global leadership summit. d. Motion Item #1: Adoption of Ordinance No. 57 - City of Grant Fire and Emergency Services Fee:

e. Motion Item #2: First Reading: Proposed Ordinance No. 55-2 amending Ordinance No. 55 (Amendments for Regulations for Businesses and Related Activity, regarding Medical Marihuana)

Motion: Motion made by Block, second by Sanchez to approve the first reading of Ordinance 55-2. Motion carried with five Yes to one No.

f. Discussion Item: Ordinance No. 15-6: Parking: Chief Wade explained issues brought up about people parking between the sidewalk and the roadways. People were told to not park over sidewalks or on roadways. Since 1973, more vehicles are around. There are more vehicles in each household now. SGT Paulsen spoke to these residents, and they were not aware of this ordinance. Some homes have concrete or crushed concrete, but they are not allowed. Things have changed since 1973. Kasey's issue is that previous City Managers have given approval.

Williams asked if it's for homeowners only, or anyone.

<u>Pickard</u> suggested people park in their garages or driveways.

<u>Hallman</u> would like to see us re-write this section of the ordinance.
