c. Festival Horseshoe Tournament request: Request to allow consumption of beer at Blanche Lake Park between 9am and 3pm on Saturday, August 17, 2013.

Fett expressed his desire to restrict to allow canned beer only.

<u>Weeks</u> expressed concern about glass containers, as well as not restricting beverages to just beer. She would like to allow canned alcoholic beverages so that other alcoholic beverages would also be allowed for those that do not drink beer.

Motion: Motion made and amended by Hallman, second by Smith to allow consumption of canned alcoholic beverages only at Blanche Lake for one day only on Saturday, August 17, 2013 with the following requirements:

- (1) Only canned beverages, and absolutely no glass containers allowed
- (2) Consumption allowed between 9am and the end of the Horseshoe Tournament (approximately 3pm)
- (3) To require the Chamber of Commerce to perform identification checks before and during event
- (4) To require police to monitor the event and to enforce end of alcohol consumption at the end of event
- (5) To require the addition of City of Grant as an additional insured on the Grant Area Chamber of Commerce Festival insurance policy.

Motion carried unanimously.

- a. CSX Property: Doug explained that he is trying to get pricing together and also look for other possible funding sources. It is likely going to be fall before we can move on this.
- b. Amphitheatre project: Doug just met with Jason McKinley about this and the Sidewalks project to discuss timelines.
- c. Sidewalks project: The sidewalks on Elder will be started this Thursday and will be wrapped up by the end of next week. State Street sidewalks should be done within three weeks. Only one home will be affected by this project.

<u>Pickard</u> asked when Commerce Street paving will be done, and Doug replied that once we are ready to go, it will be a very short notice before the work begins.
