Pickard pointed out that minor mechanical repairs are fine for maybe thirty days. Do we allow a year? Smith stated we have better things to do than ask people to start their car every thirty days.

Hallman stated his wife didn't want to see it either.

Mendham stated the ordinance was written to prevent backyard mechanics. We have to be really careful when enforcing these ordinances with many residents who may not be able to afford to fix their vehicle. Hallman commented that "uniform enforcement" is not always practical. Perhaps talking to new neighbors might work better. We try to work with people, but perhaps a year was excessive.

Weeks mentioned the pig issue in October. Appreciates uniformity in enforcement of the same ordinances.

Rudzis stated that if we enforce a fire uniformly, a fire could take two weeks to be put out.

Hallman recalls from years ago that a vehicle has to have a valid plate and be operable.
