# Appendix C

#### 2007-2012 Recreation Plan Goals

1. "Promote active lifestyles through recreational opportunities that encourage children and adults to stay active."

The City of Grant rebuilt the Ryan Benson Memorial Skatepark with grant funding from the FACF. The Skatepark was rebuilt with all steel to promote physical activity as well as durability for the park facility.

Blanche Lake Park had the addition of a new boat launch and new ADA dock. Along with some invasive weed/muck treatment, these improvements with the lake were/are intended to foster increased usage for recreational activities.

2. "Increase visual appeal of current facilities to promote existing recreation opportunities as attractive, safe, and regularly enjoyed by the public."

The City improved the visual appeal, preservation of several facilities over the past 5 years. In 2008 the City partnered with individual donors, the Chamber of Commerce and the FACF to secure property for a new Park on the Westside of M-37, which is now Water Tower Park. The Water Tower was moved and renovated to its original character and the City was able to get the Water Tower Historical Marker plaque from the Michigan Historical Commission.

The City was able to secure grant funding from the FACF and assistance from a local welder to rebuild the wooden skate park structure in 2009. The skate park structure no longer suffers blight and safety issues from the wood structure. The City also added a security camera that is available to be viewed on the internet to promote safety of those using the park in 2010.

The Community Building was significantly overhauled in 2009-2010. The building received over \$200,000 in upgrades thanks to the FACF. The facility received a brand new roof, removed old drop ceiling in the main hall (restoring it to its original height), new windows (replacing the 1960's windows), enclosed entryway and new ADA compliant restrooms, new HVAC, new insulation, new lights, and ADA entry ramp in the front of the building.

In 2009 the City upgraded the old dilapidated dock at Blanche Lake Park with a new, larger, floating dock. The City subsequently added a paved boat launch. In 2010 a new volleyball court was added to the park as a donation from the Chamber of Commerce.

All of these improvements have added to the visual appeal and promotion of community facilities.

3. "Provide valued recreational opportunities that do not require user or service fees from residents for participation."

Upgrades made to Blanche Lake Park, including a new volleyball court, dock, boat launch, and weed/muck treatments and rebuild of the Ryan Benson Skatepark have all been completed to continue to offer recreational opportunities for citizens. There are currently no fee related activities or passes to use City parks. Grant Public Schools offers fee related camps and recreation activities within the City during the summer.

4. "Protect and promote our City's water resources"

The City has promoted its water resources at Blanche Lake Park by adding and publicizing in newsletters a new dock and boat launch in 2009. The City has also done invasive weed and muck treatments in 2011 to help preserve and promote the lake and water resources.

5. "Provide unique recreational opportunities to keep our youth interested in recreation activities and attract facility users from outside of the Grant area."

The City has invested in a Skatepark rebuild to increase safety, durability along with a security camera.

The City has invested over \$200,000 in the Community Center to address visual aesthetics, functionality, and comfort as well as code issues.

Blanche Lake has received new upgrades with dock/boat launch, weed treatments, new volleyball court and a new restroom facility that was identified as a need in the previous parks and rec plan.

The City also added some way finding signage around the City in 2008 to better direct citizens to community park assets.

6. "Develop new, and upgrade current facilities that ensure accessibility to all visitors, regardless of disability."


The Community Center received significant upgrades to bring the interior as well as exterior into compliance with ADA accessibility. Blanche Lake also has a better accessible dock for those who are handicap and a handicap accessible restroom facility.

7. "Ensure that the City of Grant's funding levels dedicated to its Parks and Recreation opportunities are adequate to accomplish the goals outlined in this Plan."

The City of Grant has tried to maintain adequate funding levels for parks and recreation facilities. As a whole, with dollar amount figures for capital improvements made to Water Tower Park, Community Center, Ryan Benson Memorial Skatepark and Blanche Lake Park, the City was able to far exceed the funding objective set out in the previous parks and recreation plan that recommended 10% of general fund revenues be set aside for parks. The City has been successful with securing donations, volunteer labor and grants from the FACF to fund these efforts in concert with the parks and recreation plan.



Spectrum Health and the Grant Area Chamber are interested in doing this again next year.
