Jernberg – our GPD Sgt Patterson has issued warnings to 2 homes recently and will continue to follow up Hallman – some residents continue to receive warnings to mow and will do so at the last moment avoiding a fine. Jernberg – at our next meeting we can review the ordinance code and have further discussion
